Odd Society Spirits is proud to offer you the opportunity to own your very own private 30 litre cask of Canadian Whisky. Choose from a single malt whisky, single malt peated whisky, or 100% rye whisky.

Your Single Malt will age at the Odd Society Distillery for three years and will then be bottled for you to enjoy. During this time, you can follow the aging process with periodic tasting events.

This limited offer includes

30 litres of Odd Society Single Malt <code>barrelled</code> at 62.5% ABV

Storage for three years while the spirit matures in once-used American White Oak Bourbon casks at the Odd Society Distillery

Bonding and insurance for three years

Visitation and tasting events at the Odd Society Distillery in year one and year two.

Can I keep my cask at home?

Sadly, no. Liquor regulations prohibit the sale and delivery of bulk spirits to individuals so we will hold your spirits while they age and then bottle them on site for you.

What about bottles, labels, corks?

All are included in the bottling price of \$350.

Can I get my own personalized labels?

Yes! Personalized labels are possible, but at the expense of the purchaser. All labels must meet the labelling regulations set out by the Canadian Food and Inspection Agency and be ready and approved prior to bottling.

How many bottles will I get?

We can't predict exactly how many bottles your cask will yield due to evaporation rates and differences in each unique barrel. However, one 30 litre cask bottled after three years at 40% should yield approximately 60 500 ml bottles.

Evaporation?

As your spirit matures, the cask contents decrease due to evaporation, which is completely normal. In Scotland, it's called the "Angel's Share". Losses per year are expected to be approximately 10%-12% per year in a small barrel.

What percentage will it be? We bottle with a filling strength of 40% ABV.

Is this Whisky?

Not yet, but it will be! Canadian liquor regulations forbid us from calling anything that hasn't been aged for three years a whisky. So while it ages in the cask, we'll call it a Single Malt spirit, but when it's done aging we can officially call it a Single Malt Whisky.

Small Print

- All tax included: Federal Excise Tax, provincial LDB markup, GST and PST at current rates. Future increases and changes in tax rates that apply at the time of bottling are not included and will be payable at bottling time.
- Payment in full for the cask contents required at time of ordering.
- Bottling costs are \$350, payable at time of bottling, tax included.
